INITIATIVES

The employment unit engaged in the following broad outreach initiatives in accordance with various elements of FCC Rule 73.2080(c)(2):

Co-sponsored at least one **job fair** with organizations in the business and professional community whose membership includes substantial participation by women and minorities.

The Stations partnered with the Workforce Center/Rural Human Services in the Coastal Job Fair April 18th, 2017. The event was held at the Del Norte County Fairgrounds, Crescent City. The fair was hosted by Rural Human Services Work Force Center, Crescent City. Stations participated as co-host, and provided live remotes from the event.

Participated in **job banks**, **internet programs**, and other programs designed to promote outreach generally (i.e., that are not primarily directed to providing notification of specific job vacancies).

The Stations present a weekday program entitled "Hot Jobs" offering the latest employment opportunities in the community. We partner with the Del Norte Work Force Center, Rural Human Services and local businesses by offering a daily radio report (Mondays & Tuesdays at 9:50am) of current job openings and job training opportunities. The Hot Jobs Program includes JOB FINDER TIPS OF THE WEEK provided by the Del Norte Work Force Center. It is an educational segment which airs 6 times per week on our Bicoastal Media Radio Stations, following the weekly listing of HOT JOBS.

Established training programs designed to enable station personnel to acquire skills that could qualify them for higher level positions.

The General Manager attended a Management Workshop training session, Dec. 21, 2016 via webinar.

All staff was required to attend training on stopping sexual harassment, and an annual update on labor laws

and opportunities for advancement within the industry. The program was held at the studios and presented by the General Manager on May 19, 2017.

Participated in at least 4 events or programs sponsored by educational institutions relating to career opportunities in broadcasting.

All three stations partnered with the Summer Youth Training Academy, hosted by Building Healthy Communities and Youth Training Academy. The summer program runs July and August 2016 and 2017. Stations provided training and education for 15 students.

All three stations partnered with the Del Norte County Unified School District's Workability 1-Transition Partnership Program, assisting high school students to transition into the workforce. The Program ran through September 30, 2016. The stations provided on air interviews and educational messaging to promote the program.

All three stations partnered in the Building Healthy Communities Youth Media Session July, 2016 at the studios. 15 Students participated in radio voice over training and production for educational outreach messages.

Sponsored at least 2 **events** in the **community** designed to inform and educate the public as to employment opportunities in broadcasting.

The Stations are actively involved in most of the biggest community events throughout the year. We constantly strive to educate the public during these events about radio employment opportunities, to partner with events/promotions, and to create growth in local businesses by creating job opportunities, such as:

 The Stations sponsored/partnered with the Chamber of Commerce: Economic Summit-Northern California on March 17, 2017, presented by the Del Norte County Chamber of Commerce at the Elk Valley Rancheria Community Center-Crescent City. The General Manager and sales staff hosted a booth providing information about potential broadcasting employment opportunities.

Participated in other activities designed by the station employment unit reasonably calculated to further the goal of disseminating information as to employment opportunities in broadcasting to job candidates who might otherwise be unaware of such opportunities.

All three stations partnered in the Crescent City-Del Norte County Chamber of Commerce Regional Seminar and Awards night, January 28, 2017 at the Howenquet Hall in Smith River, CA. Stations provided information about the broadcast industry and potential career opportunities.

The stations were involved in the following emergency preparedness activities, which serve to highlight the role

of radio in the community:

- 1. The General Manager and Operations Manager, participated in the PIO Crisis Communication and organizational meeting. The General Manager was the media representative for local radio and the role "radio" plays during community disasters. Approximately 20 agencies were involved in the exercise and were exposed to industry information and broadcast opportunities. Brochures regarding potential broadcast employment opportunities were made available at the event held at the CFPD Fire Hall, Washington Blvd, Crescent City and the Crescent City Airport on January 6, 2017.
- 2. Monthly Chamber of Commerce meetings at rotating locations are attended by (at least) one station employee per month who represents Bicoastal Media and discuss current employment opportunities.
